## Introduction

Across the United States, landowners with 1-9 acres of land constitute over 60% of the landowner population; however, they own less than 7% of the total acres of private forestland. A majority of the these small parcel owners are Woodland Retreat type owners, who appreciate the amenity values of woods.

Landowners with smaller lots are less likely to be enrolled in government programs or do traditional forestry activities on their lands. The are more involved with activities such as eliminating unwanted insects and disease from their land and reducing fires hazards. They are more likely to be residential lots and are less likely to have attached farms or ranches or to have vacation homes. The typical concerns of larger parcel landowners, such as taxes, trespassing, and keeping land in tact for future generations, don't typically apply to smaller parcel landowners, who are more concerned with air quality, climate change, development, and invasive species.





### **TELE Segmentation**


Shows how the landowners in this group are distributed among the TELE attitudinal segments.



**95**% of the landowners are classified as Prime Prospects. This means they have good stewardship attitudes but are not highly engaged in managing their land.


### **Reasons for Owning Woods**

The percentage of landowners in this group who said they are concerned or greatly concerned about each of these factors.




## **Activities on the Land**
