

Introduction

Nationally, about 17% of woodland owners have harvested timber in the past. Most of these people own larger tracts of land and have owned the land for at least a decade.

People who have harvested timber are more likely to value their woods for financial reasons instead of, or in addition to, amenity reasons and generally support active management of woodlands. These folks care about protecting the long-term viability of their investment. Although they are more likely to have received information about woodland management in the past five years, and often have management plans and participate in cost-share programs, the numbers are still fairly low.

For those people who are not engaging in other stewardship activities, one barrier could be that they only see value in activities that bring a direct payout. Others may also have fixed views about management and be unwilling to seek advice from professionals. Providing them with good reasons for planning and getting professional advice can increase the value of their harvest and assure it maintains forest health for the future.

Basic Statistics



Size of Holdings



SFFI Segmentation


Shows how the landowners in this group are distributed among the SFFI attitudinal segments.

Reasons for Owning Woods


The percentage of landowners in this group who cited each of these reasons for owning land as important or very important to them.

The percentage of landowners in this group who said they are concerned or greatly concerned about each of these factors.




Activities on the Land

SFFI classifies **19%** of the landowners in this group as highly engaged. This means that they have reported doing several activities to protect and improve their woods.

The dark green bars show the proportion of woodland owners in this group that have done each of these activities in the past five years. The light green bars show the proportion who say they are likely or extremely likely to do that activity in the next five years.

Future Plans

93% of these landowners want their wooded land to stay wooded.

23% say they plan to sell or transfer their land in the next 5 years.

22% say they would sell their land if offered the right price.

59% have an annual income of less than \$49,000

27% rely on their woods for at least 5% of their income
